Campaign to Renovate the Alpha Psi Chapter House

PLEDGE FORM

The fraternity house at River Falls that we're so fond of is facing some challenges:

- New laws require that a fire suppression system (sprinklers) be in place by 2011.
- The dormitory portion is almost 40 years old and is showing the wear and tear of being lived in by three generations of young men.
- Its late '60s-era single-pane windows and minimal insulation means larger-than-necessary energy bills.
- The flat roof doesn't leak...yet...but will need work soon.

Working together, we can ensure the future of Alpha Gamma Rho at UWRF, by ensuring that we have a chapter house that meets the needs of future brothers.

HOW YOU CAN HELP

After years of discussion and consideration, the Alumni Board has begun a "Campaign to Renovate the Alpha Psi Chapter House." We're asking Alpha Psi's many Brothers, spouses, Rho-Mates and friends to contribute in a variety of ways.

We expect most people will help us with:

- Cash Gifts (tax-deductible checks payable to "Alpha Gamma Rho Foundation-Alpha Psi" or non-tax-deductible checks to "Alpha Psi Alumni Association"), and
- Pledges (a commitment to contribute in single or multiple installments for up to five years, depending on your personal financial goals).

YOUR PLEDGE IS IMPORTANT

It is understood the Alpha Psi Alumni Board of Directors will reasonably act – relying upon your pledge – to borrow money, incur expenses, enter into contracts, or undertake projects or obligations toward the chapter house renovation project.

TAX-DEDUCTIBLE GIFTS

Contributions to the Campaign through the "Educational Foundation of Alpha Gamma Rho-Alpha Psi Chapter" are Tax-Deductible and the Foundation is recognized under section 501(c)3 of the Internal Revenue Code. (Federal Taxpayer ID #36-6158409)

This will ensure that a tax-deductible contribution can be used to enhance the educational facilities of the chapter house and further endow our scholarship programs.

NON-TAX-DEDUCTIBLE GIFTS

However, to complete the renovation project with minimal borrowing costs, we also encourage non-tax-deductible contributions. This will help fund the portions of the house that cannot be classified as educational in nature.

Contributions to the "Alpha Psi Alumni Association" are Non-Tax-Deductible, but are essential for achieving the goal of enhancing both the educational and non-educational facilities of the chapter house.

MATCHING CONTRIBUTIONS

If your employer offers a matching contributions program, you may be able to double your contribution to the Campaign. Please ask for a Matching Gift Form from your company's Human Resources or Public Relations department and include it with your pledge.

We hope you can contribute – and ask those Brothers, Rho-Mates and friends you know to do so, as well.

LEAD GIFTS

One of the Brothers has already pledged \$15,000 and has issued a challenge: He will donate another \$10,000 if at least 3 other Brothers donate a minimum of \$10,000 each.

We anticipate that other donors may contribute similar Lead Gifts, as well.

MONTHLY GIFT CALCULATIONS

Depending on your personal financial planning and goals, you may choose to spread your gift over a period of months. If so, this option may also allow you to increase the size of your gift.

For example, a \$5,000 gift over a 5-year-period is roughly \$20 per week or about \$2.75 per day.
